Department Notification No 1147/Gen. dated 17.01.2014.**CONDITIONS OF SERVICE:** Condition of Service for the post shall be governed by the Odisha Detective Dog Squad Service(Method of Recruitment and condition of service) Rules,2015 notified by Govt. in Home Department Notification No.37593-Home-D&A dated 07.11.2015.**ELIGIBILITY**

- i) **Age:** Must not be below 21 years and above 25 years of age as on 1.1.2017.
- ii) **Upper age relaxation limit:** 5 years in case of ST, SC, SEBC Category candidates and period of service rendered in armed forces in case of Ex-SM. There is no age relaxation to In-Service Contractual Employees.
- iii) **Educational Qualification:** The candidate must have passed Bachelor in Veterinary Science (B.V Sc.). In case of non-availability of candidates, the candidates having B. Sc with Honours in Zoology from a recognised University shall be eligible for the post. As such the candidates having B.V.Sc. & B.Sc. with Hons in Zoology shall be eligible for the post. The candidates who have not taken Odia as a subject in H.S.C standard, must possess requisite certificate of passing ME standard in Odia as language subject.
